Mr. Jones made a motion seconded by Mr. Francis to proclaim April as Fair Housing Month. Motion unanimously approved.

Councilmen Lester Francis and Tommy Sandifer gave the Street Committee update. A committee meeting was held March 30, 2022, at 10:00 a.m. Repair work with the LaSalle Parish Police Jury continues. The town continues to use the police jury's side bush hog to clean up rights-of-way.

Assistant Fire Chief Charlie Savell presented the Fire Report.

Police Chief Scott McLendon presented the police report.

Superintendent Ronny Steele presented the utility report.

Mayor Edwards announced that new signed for the 3A Softball State Champions have been placed at each end of town along Hwy 84.
