The reading of the minutes of the previous meeting was dispensed on a motion by Mr. Chapman and seconded by Mr. Francis. Motion unanimously approved.

Mr. Francis made a motion seconded by Mr. Richardson to approve the financial reports for March 2023. Motion unanimously approved.

Mr. Chapman made a motion seconded by Mr. Richardson to adopt the millage rate for the tax year 2023. Motion unanimously approved.

Mr. Richardson made a motion seconded by Mr. Jones to approve the 2022 Louisiana Compliance Questionnaire. Motion unanimously approved.

Mr. Chapman made a motion seconded by Mr. Francis to introduce an amendment to Ordinance 131-Personnel Polices. Motion unanimously approved.

Mr. Francis made a motion seconded by Mr. Chapman to introduce an amendment to Ordinance 157-Utility Rates. Motion unanimously approved.

Firefighter Jeffery Benson presented the Fire Report.

Police Chief Scott McLendon presented the police report.

Superintendent Ronny Steele presented the utility report.

Mayor Edwards announced that Easter in the Park had to be canceled due to rain. Thank you to Beverly Young for all her hard work in preparing for the event.
